Sir/Madam,

With reference to your application on the subject cited above, I am directed to convey the approval of the Competent Authority i.e., Director (Education) for Grant the extension of provisional upgradation upto Secondary level in r/o Shri Tula Ram Public School, D Block 111/1, Rama Vihar, Mohd-pur Majri, Delhi 110081 under RTE Act, 2009 w.e.f. 01.04.2026 to 31.03.2031, subject to following conditions:-

- (i) Final outcome of the notification of MoUD, GoI.
- (ii) That the school shall make payment of salary and other admissible allowances to its teaching/non-teaching staff as per ongoing CPC through bank/RTGS.
- (iii) That the school shall comply with clause 14 of order no. F.DE/15(56)/ACT/2009778 dated 11/02/2009 in r/o maintenance of DRF. School also ensure to the follow FN-21 "Accounting by school" as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
- (iv) That the school shall comply with the provisions of section 10(1) read with Rule 125 of DSEAR, 1973.
- (v) That the school shall comply with the provisions of DSEAR, 1973, RTE Act, 2009 and direction/instruction/guidelines issued by the Department from time to time.
- (vi) That the school shall comply with the order/guidelines of DoE and judicial pronouncement w.r.t. utilization/ maintenance of school funds.

(vii) That the school shall appoint trained graduate teachers as per notified recruitment rules.

(viii) That the school shall submit an undertaking to DDE North West B-II that the school complies with the orders/guidelines of DoE dated 07/11/2017 and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.

(ix) That the school shall comply with the section 17(3) of DSEAR, 1973.

(x) That the school is not run for profit to any individual, group or association of individuals or any other persons.

(xi) The school shall admit in the entry level class, to the extent of 25% of the strength of that class, children belonging to the weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion.

(xii) The school shall submit the documentary proof of appointment of Special Educator to DDE North West B-II within 30 days.

(xiii) That the school shall comply with the orders F.No.DE.15(305)/PSB/Misc/2020/Pt. File-11/5641-5647 dt. 20/06/2023 regarding submission of renewed/updated certificate like Fire NOC, Water Test Report, School Health Certificate, School Building Fitness Certificate/Structure Stability Certificate to the Zonal Authorities of DoE.

(xiv) That the school shall comply with the provisions of sections/Rules 176,177,18(15),17(3) of DSEAR, 1973 order dated 15.12.1999, 10.05.2005, 11.02.2009, 16.04.2010 and 19.02.2016 dealing with the regulation of fee along with the subsequent orders issued by DoE from time to time.

(xv) That the violation of any instructions/orders/rules and regulations of the department, shall lead to withdrawal of recognition of the school.

(xvi) That the school shall ensure that the Fire safety equipment and arrangements are maintained as given in circular No 262-362 dated 17/01/2005 and corrigendum dated 27/01/2005 and circular NO. 3298-3398 dated 01/03/2011 issued by the Directorate of Education.

(xvii) That the school shall not run any unauthorized classes / section including Pre-Primary and Pre-School without prior approval of the Competent Authority.

(xviii) That the DDE district shall ensure that the aforesaid terms & conditions are being complied with by the school management in letter and spirit.
